PREFACE.

By order of Government, the Department of Statistics published, after the decennial population census in 1330 F. (1921), tables volume of the District Gazetteers setting forth in details talukwar statistics of population, agriculture, land revenue, education, justice, etc. That being the first attempt it was not possible to compile more than 33 tables. They were intended to serve as companion to the Descriptive District Gazetteer volumes.

After the next census in 1340 F. (1931) the Department took up the revision of the tables and in the course of the work it was found expedient to alter the whole structure of the Gazetteer by enlarging the contents and presenting the data in two languages as approved by the Government. Although it was intended to speed up the work and bring out the volumes with as little delay as possible, the "Statistical Year Books" which displaced the decennial "Statistical Abstract" had to be given preferential treatment. Consequently, the District Statistical Gazetteer containing as many as 124 tables of talukwar data for the decennium ending 1340 F. was delayed; but to compensate for the delay, statistics to the end of 1345 F. were incorporated.

Thus the present edition carries statistics for 15 years—details for 1340 and 1345 F. and consolidated figures for the preceding 14 years for comparison.

As per Government order the subsequent issues will be quinquennial.
